Abstract:

Neither a single researcher, nor an institution alone can tackle the societal challenges that lie ahead. The complexity of challenges requires a 'Team Science' approach with large consortia, leveraging the strengths, expertise and perspectives of academics and non-academic partners from different fields, sectors and countries. Tackling of future challenges require new skills sets, learning methods and new ways of thinking.

Una Europa's DocProg will provide 45 Early Stage Researchers (ESRs) with the unique opportunity to access a large pool of high-quality interdisciplinary research options that cannot be offered by one university alone ('Team Science' approach). The programme will launch one international call for applications, allowing ESRs to complete their doctorate within three or four years - according to their chosen track. Una Europa will focus this doctoral programme, Una Europa DocProg (DocProg), on two of its defined focus areas: Cultural Heritage (CH) and One Health (OH). Una Europa has defined five multidisciplinary and challenge-based focus areas to launch collaboration. These focus areas act as the initial thematic "glue" that ties the universities together in the mission to create a virtual campus.

By offering a true 'Team Science' approach, the goal of DocProg is to prepare ESRs for the future, providing them with excellent research skills and interdisciplinary, transnational and inclusive training required for future careers – within or outside of academia.

STRENGTHS

- The dissemination strategy for advertising calls will be based on an appropriate set of channels for passing information to a broad range of candidates from all over the world.
- The information to the candidates is adequate and has the potential to attract early stage researchers.

- The eligibility criteria and the application requirements for the candidates are properly outlined.
- The evaluation criteria and the scoring procedures are clearly presented.
- The Applicant and the partners demonstrate sufficient range of instruments to safeguard equal opportunities during the whole implementation of the project. This includes in particularly ensuring gender balance and necessary arrangements for disable researchers.
- The programme has the potential to offer various research topics to the candidates.
- The proposal demonstrates well the beneficiary's commitment to promote interdisciplinarity, intersectoral and transnational mobility, profiting from a broad European network of partners in academia and the private sector.
- The proposed academic supervision arrangements are clear and relevant.

WEAKNESSES

- The selection process is not fully transparent in terms of scheduling and the preselection stage when the supervisor will select one or two candidates.
- The proposal insufficiently addresses the composition and organisation of selection committees. The selection criteria for internal and external evaluation experts are not clearly presented .
- It is not evidenced if the external experts will be involved in all stages of the selection process
- The training options for both research-specific training and training in transferable skills are presented only in general terms, lacking specific details on content and timing.

Criterion 2 - Impact

STRENGTHS

- The programme has strong potential to enhance future career prospects of researchers.
- The proposal demonstrates well its impact on strengthening human resources on regional, national and international level through the supervision and secondments arrangements as well as on business creation through cooperation with non-academic partners.
- The proposal adequately describes how the programme will align itself with the European Charter and Code of Conduct for Researchers and the EU Principles for Innovative Doctoral Training.
- The proposal presents effective strategies for dissemination and exploitation of the research results with information on clearly set up channels and expected outputs included.
- The proposed measures to communicate the results to different target groups are sound. The communication activities will be supported by the previous experiences and the already developed communication tools across the member universities.

WEAKNESSES

- The proposal inadequately addresses the open science principles.
- Data management, IPR issues and IP policies are not presented convincingly for such an ambitious programme.

STRENGTHS

- The gantt chart is coherent and the work plan is elaborated well, organised around six work packages with clear objectives, milestones and deliverables and with a realistic timeline
- Risk management is properly addressed and an effective mitigation plan is proposed.
- The appointment conditions of researchers are of good standards and in line with MSCA Guide for Applicants individual Fellowship and according to national regulations with full social security coverage.
- The proposal adequately demonstrates the relevant competence and operational capacity of the applicant and the participating universities to implement the programme.

WEAKNESSES

-The budget of the programme is inconsistent and does not fully cover all the proposed support mechanisms. For example, coverage for the appointment's conditions and mobility allowance for all the ESRs targeted in the programme are not clearly described.
